

Released May 15th, 2020**Canadian Emergency Wage Subsidy (CEWS) Extended**

Finance Minister Bill Morneau announced today that the Government of Canada will extend the CEWS by an additional 12 weeks to August 29, 2020. The Government will consult with key business and labour representatives over the next month on potential adjustments to the program to incent jobs and growth, including the 30% revenue decline threshold.
