


Summer Updates from HR Performance & Results

Accessibility Compliance Report due December 31, 2023

The Accessibility for Ontarians with Disabilities Act (AODA) is a provincial law that aims to identify, eliminate, and prevent barriers, and foster inclusion for persons with disabilities. The Integrated Accessibility Standard Regulations (IASR) has five standards that government, public sector organizations, private businesses, and non-profits must comply with in order to be accessible to persons with disabilities.

• One of the legal requirements under the AODA is that businesses and non-profit organizations with 20 or more employees in

- Ontario file an Accessibility Compliance Report every three years. **The reporting deadline is December 31, 2023.** For information on filing your Accessibility Compliance Report, contact us today.
- Another legal requirement under the AODA is to provide training to your employees on the AODA and the Ontario Human Rights Code as it relates to persons with disabilities. New Heat Stress Regulation Proposed under the OHSA

On August 1, 2023, the Ministry of Labour, Immigration, Training and Skills Development proposed a new heat stress regulation under the Occupational Health and Safety Act. This regulation has been proposed due to the increase in temperatures and extreme heat over recent years, which has led to concerns about heat-related illnesses in the workplace. As our climate continues to change, heat stress and other heat-related occupational illnesses present an increased hazard to workers.

It is important to note that this proposed regulation is at the preliminary stage only. We will monitor the proposal and provide updates as they become available.

Essentials of Supervision – Workshop Series


