## Working for Workers Updates

Over the last several years, a series of Working for Workers Acts aimed at addressing and improving working conditions for Ontario workers have been passed. The following are a few key updates on the Acts.

Working for Workers Four Act, 2024 (Bill 149) and Working for Workers Five Act, 2024 (Bill 190)

In March and October of 2024, both bills received royal assent amending employment-related legislation in Ontario. Key provisions of the Acts were to be proclaimed into force at a later date.

On December 3, 2024, the Ontario government released the dates these amendments will come into force and published regulations for implementing these amendments, with the majority occurring in July 2025 and January 2026. Further details can be found in the following regulations:

### Working for Workers Six Act, 2024 (Bill 229)

Building on the previous five Working for Workers Acts, on November 27, the Ontario Government introduced Bill 229: Working for Workers Six Act, 2024, which proposes further changes to key pieces of employment legislation including, but not limited to the ESA, OHSA, and WSIA. As of December 16, the Bill has reached the Third Reading stage. We will continue to provide updates on the status of Bill 229.
